1. I/We agree that while participating in said athletic activity, I/We and our child will fully comply and follow all rules and regulations of the District, including any and all rules, regulations or conditions required before my child is allowed to participate in said athletic activity. I/We further agree that if any such rules, regulations and/or conditions are not fully complied with, the District may deny my child's participation in said athletic activity. I/We further agree that if we have knowledge that our child has not complied with all conditions for participation, including but not limited to the requirement for a physical examination, we will notify the District of the same and understand that our child will not be allowed to participate until such conditions have been satisfied.
2. I/We fully understand that there are inherent risks to students who participate in said athletic activity regardless of the feasible safety measures that may be taken.
3. I/We agree to retain and to have in place at all times an insurance policy that covers any loss, damage, or injury to my/our child and by executing this agreement state affirmatively that I/we have such insurance.

I/We agree that the district will not be responsible for any loss, damage, or injury to my child as a result of my child's participation in said athletic activity, nor any loss, damage, or injury to my child as a result of my/our failure to comply with the conditions for participation in said athletic activity, and hereby agree to accept responsibility for any loss, damage, or injury to my child that occurs during my child's participation in such athletic activity or any loss, damage, or injury to my child as a result of my/our failure to comply with the conditions for participation in said athletic activity that is not the result of fraud, willful injury to a person or property or the willful or negligent violation of a law by a trustee, employee, or agent of the District;

I/We agree to release, indemnify and hold harmless therefore the District, for itself, officers, board members, administrators, employees, agents, sureties, assigns, successors, insurers, and indemnitors from any and all sums of money, accounts, suits, proceedings, claims, causes of action, rights, damages, attorneys' fees, costs and demands of any nature whatsoever, whether real or contingent, known or unknown, direct or indirect, liquidated or otherwise, arising out of or relating in any way to my child's participation in activities on or off school property or my/our failure to comply with the requirements and obligations contained herein.

6. I/We further agree that in the event it becomes necessary for the district to obtain emergency care for my child, the District will not and does not assume financial liability for expenses incurred because of an accident, injury, illness, and/or unforeseen circumstances.
